OVERVIEW:

The Tsuut'ina Nation Gas Stop provides fuel, tobacco, and confectionery items to all customers, and is also tax free with a status card.

Business has grown in the last 10 years and continues to be the #1 company within Tsuut'ina Nation Enterprises.

CHILA LOCATION:

The first location was established with humble beginnings that started as a simple construction trailer.

TAZA LOCATION:

The newest location established by Tsuut'ina Gas. Hosting a wide variety of firsts for Tsuut'ina Gas such as hot food and LCD pumps.

TSUUT'INA GAS HISTORY:

HUMBLE BEGINNINGS:

When Tsuut'ina Gas was established in 1990, it operated in an ATCO trailer. The business was later expanded into a larger facility equipped with a mechanical shop, office space and food service.

That facility was later removed to make way for the Ring Road construction and the new Tsuut'ina Nation Gas Stop facility was completed and opened in 2015.

The Taza location had its official grand opening on July 18, 2024, the business is continuing to expand and future locations are being considered.

VISION STATEMENT:

To provide an excellent golf experience to its members, Tsuut'ina members and the public both on the course and the restaurant. To be recognized as a premier golf facility in Alberta and Canada. To be a model and a place to develop Tsuut'ina members, First Nation members and the surrounding communities to ultimately employ them for a better future.



OVERVIEW:

In 1940, a brush fire destroyed most of the area known as Redwood Meadows. The Elders of the Tsuut'ina Nation noticed that after the brush fire, the regrowth of the poplar and spruce trees had a reddish color to them. The Elders then called this area "Redwood Yards". In 1972, the Tsuut'ina Nation embarked on an economic development endeavor,

to construct an 18-hole championship golf course. Owned and operated by Tsuut'ina Nation and recognized as one of Western Canada's finest championship layouts. The course was designed by Golf Course Architects Bill Newis and Stan Leonard.

The greens and landscaping were redesigned by Golf Course Architect Garry Browning in 2001.

ACHIEVEMENTS:

- Since renovations in 2021-22 were conducted, both revenues and memberships have increased
- In 2023, Redwood Meadows Golf Club applied and received a grant from the provincial government for the expansion of the kitchen (Redwood Yards)
- In 2024, Redwood Meadows Golf Club hosted 18 golf tournaments

During 2024 Redwood Meadows Golf Club had 32,500 rounds of golf played

HISTORY:

Tsuut'ina Security Company was established in 2022, and has expanded to 22 licensed security guards and striving towards licensing the company to acquire contracts for larger events off the Nation.

The Company is providing security services for Stoney Nakoda - Tsuut'ina Tribal Council (G4),

Opulence Alliance Events and certain events at the Seven Chiefs Sportsplex.

The Company is pursuing to establish security services at the Grey Eagle Event Center and sacred areas on the Nation.

OVERVIEW:

Tsuut'ina Security Company provides services to: Tsuut'ina Gas, Seven Chiefs Sportsplex, Tsuut'ina Administration Building, Tsuut'ina Museum, SR-1 Project and the 2025 Tsuut'ina Nation **Annual Celebrations** (Rodeo & Powwow).

Tsuut'ina Security Company was established in 2022 to address the Tsuut'ina Gas traffic overflow. To date, security for the Chief Joseph Big Plume Building and the Spring Bank Reservoir Dam Project were added to the Company's Projects.

A priority for the company is to secure contracts throughout the nation and work with external partners for security services.

The first Company on the Nation to implement a training to employment initiative in partnership with the Employment Resource Center, with this partnership we have staffed approximately 70% to our existing workforce.

ACHIEVEMENTS:

Despite facing several setbacks, the team successfully completed Phase 1 of the renovations within a reasonable timeframe. This included comprehensive exterior upgrades such as stucco repairs, roof replacement, facade repainting, and entry upgrades. Remarkably, these renovations were accomplished while the building was at full capacity. building was at full capacity, ensuring minimal disruption to its occupants.
